

## **General Guidelines and Information for Accredited Press** **at Banca IFIS NPL Meeting**

### **Registration and logistical aspects**

- Access to the Banca IFIS NPL meeting will only be possible after accreditation for the event.
- Registration of accredited journalists will take place at the foyer of the Palazzo del Cinema on Venice Lido, on Thursday September 27, from 3pm.
- Each journalist will be given a yellow badge which, for security reasons, must be worn in a visible position until the conclusion of the event. The badge is strictly personal and cannot be given to other colleagues.
- The press room at the Palazzo del Cinema will be open from 3pm until 8pm on Thursday September 27, and for the duration of the event on Friday September 28. The press room is equipped with wi-fi, a printer, two computer stations and around thirty workstations with electrical sockets.
- Documents and informative material about the event will be made available in the press room and on the website [www.nplmeeting.it](http://www.nplmeeting.it).

### **Contents, networking and interviews**

- Several days before the event, accredited journalists will receive access to the web app IFIS Live, created to promote networking between participants at the Banca IFIS NPL Meeting, and to permit the sending of questions during the event.
- This year, it will once again be possible to follow and relaunch topics and discussions on Twitter on our @BancaIFIS account thanks to the event's official hashtag: #NPLmeeting.
- All content will be uploaded online at [www.nplmeeting.it](http://www.nplmeeting.it), where you will be able to access files and materials even after the event.

### **Rules of access and behavior**

- The workshops scheduled for September 27 are reserved for operators and are not open to the press. The main conference on September 28 will be open to all accredited journalists with badges.
- We remind you that the Banca IFIS NPL Meeting is a private initiative and is by invitation only. We therefore ask journalists, operators and photographers to abide by the rules of conduct aimed at ensuring that proceedings are both peaceful and productive. Representatives of the media who show aggressive attitudes or endanger the privacy of speakers and guests present at the meeting will have their accreditation revoked, as well as that of their whole team.
